**Decision proposed by the IQAC**


**(IQAC Meeting Date: 20-08-2019)**

**During its recent meeting, the IQAC of the college reviewed feedback from various stakeholders and formulated the following decisions:**

1. As per the new curriculum (CBCS), an adequate number of faculties are required for the students to complete their syllabus within the stipulated time.
2. The departments need to be assigned the responsibility of arranging extra classes in accordance with the new undergraduate curriculum (CBCS) and making sure that extra study materials are available in cases where the current resources are insufficient.
3. New books on latest affiliated university syllabus (CBCS) of various subjects are required.
4. Sufficient desktops and laptops are required in every department for smooth running of undergraduate CBCS courses.
5. Institute should organize career counseling seminar frequently and students will be instructed to participate every career counseling seminar.
6. To conduct regular parent teacher meeting and mentoring sessions.


## Subsequent implementation by the GB of the actions suggested by IQAC
