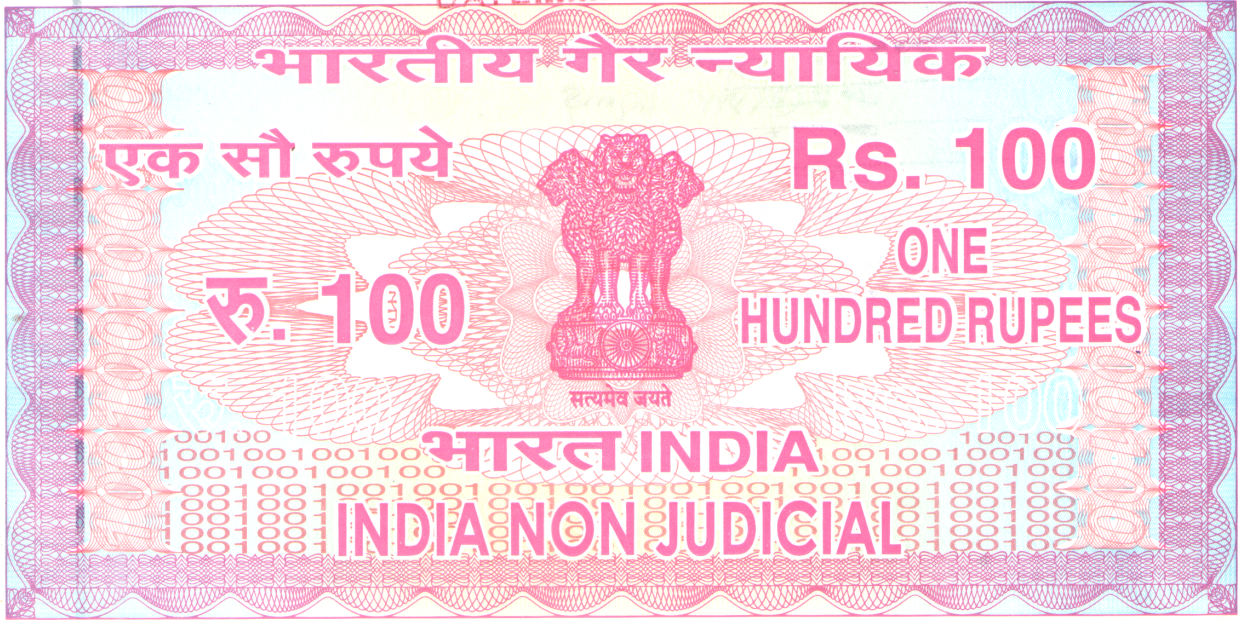
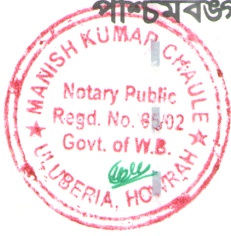



3. That the institution has constructed buildings on legally valid land as per provisions of NCTE Regulations. The square area of the existing building is 1060.84 Sq.m. and the square area of the newly constructed building is 1122.51 Sq.m. (Mouza – Uluberia, W. No.-22, Dag. No- 347 (R.S.) & 441 (L.R.) Kh. No.-1136 & 1139 (R.S.), J.L. No=109.); thus the total build up area is 2183.35 sq.m. In addition to the buildings, other instructional and infrastructural facilities have been provided as per NCTE Regulations.


